Management of Aggregate Resources looks at approvals, inspections, enforcement and rehabilitation related to the extraction of sand, gravel, clay, stone and rock in Ontario.

Metropolitan Toronto Convention Centre and Ottawa Convention Centre looks at the operations of these two convention centres.

The Operation of the *Environmental Bill of Rights, 1993* reports on the public's use of its environmental rights from April 1, 2022, to March 31, 2023, and assesses ministries' compliance with and implementation of *the Environmental Bill of Rights, 1993*.
